

# Latest Covid-19 & Visa Requirements – July, 2022



## Covid-19

The current requirement by the Indonesian government to enter Indonesia is proof of full vaccination, (first & second dose as well as the Johnson and Johnson single dose).

As of 8 June, 2022 both proof of a negative PCR test before travel and proof of health insurance that covers Covid-19 is no longer required.

You will be required to install the PeduliLindungi app on your phone. PeduliLindungi is the official COVID-19 contact tracing app used for digital contact tracing in Indonesia.

On this app you will be asked to create an account and upload your Covid-19 vaccination certificates before traveling. If you are unable to upload the certificates (it can take a few tries, and in some events doesn't work), this will not be an issue as the Bali Airport staff are available to assist. It is sufficient to just download the app on your phone and then show your proof of vaccination on arrival either by a paper printout or a digital version on your phone.

*Restrictions and requirements change frequently, and it may be that some of the above requirements have been relaxed further again by the time of your visit.*

## Visas

In order to enter Indonesia, the validity of your passport must run for at least six months beyond your date of entry into Indonesia, and you must have at least one empty page in your passport, totally clear for stamps or stickers.

Entry into Indonesia is possible for the nationals from the following countries\* by purchasing a 30 day "Visa-on-Arrival" at the time you land in Indonesia. Immediately after your arrival into Indonesia, you will be free to travel throughout the country. ASEAN passport holders are also able to enter through the Visa-Waiver program.

\* Argentina, Australia, Austria, Bahrain, Belarus, Belgium, Bosnia Herzegovina, Brazil, Brunei, Bulgaria, Cambodia, Canada, China, Croatia, Cyprus, Czech Republic, Denmark, East Timor, Egypt, Estonia, Finland, France, Germany, Greece, Hong Kong, Hungary, India, Ireland, Italy, Japan, Jordan, Kuwait, Laos, Latvia, Lithuania, Luxembourg, Malaysia, Malta, Mexico, Morocco, Myanmar, Netherlands, New Zealand, Norway, Oman, Peru, Philippines, Poland, Portugal, Qatar, Romania, Russia, Saudi Arabia, Serbia, Seychelles, Singapore, Slovakia, Slovenia, South Africa, South Korea, Spain, Sweden, Switzerland, Taiwan, Thailand, Tunisia, Turkey, UAE, UK, Ukraine, USA, Vietnam

ASEAN passport holders are also able to enter through the Visa-Waiver program. Please note that this visa free facility for ASEAN passport holders does not offer an option to extend your stay beyond the initial 30 days.

Nationals of all other countries should contact the Indonesian Embassy closest to your home to secure a visa in advance of travel.

*Since visa regulations change quite frequently, we strongly suggest that you check the above requirements with your booking agent, or with the airline you intend to fly with.*
